INTRODUCTION	At Trinity Lutheran College (the College) we aim to provide an open, welcoming, inclusive and safe environment for all.		
	All parents, guardians, step-parents, family members, and friends of students enror at the College must support and encourage the values, activities and ethos of College, and are encouraged to read and understand the policies of the Col (including this Parent Code of Conduct).		
	This Parent Code of Conduct applies to all Parents and/or Guardian/s listed in an Enrolment Agreement in connection to a student enrolled at the College, herein after referred to as " Parents ".		
	We believe that Parents are valuable contributors in our community and we aim to work in partnership with Parents in the care and growth of each student. We have a zero tolerance policy regarding violence of any kind.		
	This Parent Code of Conduct outlines the way in which the College requires Parents to conduct themselves when visiting the College campus', participating in College activities and communicating with members of our community (including students, staff and other parents).		
PARENT CONDUCT	1. Parents/Guardians/Caregivers are required to:		
	1.1. comply with all safety policies and procedures in place at the College;		
	 sign in upon arrival for any visit that is not within daily pick up/drop off routines and specific parent events e.g. Information Evenings; 		
	1.3. comply with relevant legal obligations under the legislation and any court order;		
	1.4. only enter a classroom or attend a college related activity with permission from a staff member; All parents must sign in at front reception.		
	1.5. listen respectfully, in the same manner required by students and staff, when attending any kind of College assembly, activity, presentation, class event, or public meeting;		
	1.6. treat all parents, staff, contractors, volunteers, students (including their own), and visitors to the College with courtesy and respect; and		
	1.7. when attending a college event in a voluntary capacity, accept the authority of the teacher (or teachers) and comply with any reasonable direction; and		
	1.8. comply with any reasonable direction given by a staff member of the College.		
	2. Parents/Guardians/Caregivers must not:		
	2.1. Use violence of any kind at any time;		
	2.2. disparage the College's Christian teaching or act otherwise in a manner which is disrespectful or contradictory to the College's Christian ethos;

- 2.3. interrupt or disrupt a teacher whilst classroom instructions or learning activities are taking place;
- 2.4. discipline or reprimand a child;
- 2.5. bully or harass parents, staff, contractors, volunteers, students, and visitors to the College;
- 2.6. take a photo or video recording of a child if that child is not their own child, unless the parent of the child is present at the time and consents to the photo or video recording being taken; or
- 2.7. attend the College whilst under the influence of drugs or alcohol.
- 3. When communicating with staff, contractors and volunteers:
 - 3.1. All staff, contractors and volunteers are entitled to a safe and enjoyable work environment.
 - 3.2. If a Parent contacts a staff member, contractor, or volunteer in relation to a query or concern, the recipient will respond within a reasonable period of time.
 - 3.3. In order to most effectively discuss a particular query or concern, Parents wishing to speak to a staff member, contractor, or volunteer (either in person or over the phone) must make an appointment in advance.
 - 3.4. Whilst the college will make reasonable attempts to comply with a court order, the College's priority is the wellbeing of the students and will only comply with court orders to the extent necessary. The college prefers not to become involved in family law proceedings.

4. Parents are required to:

- 4.1. speak to staff, contractors, and volunteers with courtesy and respect;
- 4.2. communicate with staff, contractors, and volunteers in a clear, friendly and open manner;
- 4.3. respect staff decisions and follow their directions; and
- 4.4. respect the privacy of staff, contractors, and volunteers.

5. Parents must not:

- 5.1. Use violence of any kind at any time;
- 5.2. raise their voice or interrupt whilst a staff member, contractor, or volunteer is trying to speak;
- 5.3. speak to staff, contractors, or volunteers in a derogatory or offensive manner;
- 5.4. use profane, insulting, harassing, aggressive or otherwise offensive language;

- 5.5. take a photo, video recording, or audio recording of a staff member, contractor or volunteer without prior consent;
- 5.6. post a photo, video recording, or audio recording of a staff member, contractor or volunteer on social media without prior consent;
- 5.7. attempt to contact staff members at their home or through use of their personal phone number, unless the staff member has permitted such contact;
- 5.8. assault (sexually or physically) a staff member, contractor or volunteer; or
- 5.9. intimidate, undermine, threaten, bully or harass staff, contractors, or volunteers.

When communicating with other students (not their own) and parents,

6. Parents are required to:

- 6.1. speak to other students and parents with courtesy and respect;
- 6.2. contribute to a positive and friendly culture within the college community;
- 6.3. support and encourage the values, activities and ethos of the college; and
- 6.4. respect the privacy of other students and parents.

7. Parents must not:

- 7.1. use violence of any kind at any time;
- 7.2. raise their voice when speaking to other students and parents;
- 7.3. use profane, insulting, harassing, aggressive or otherwise offensive language;
- 7.4. deliberately exclude a student or parent or treat a student or parent differently to other students or parents;
- 7.5. speak to other students or parents in a derogatory or offensive manner;
- 7.6. take a photo or video recording of another student or parent without their consent;
- 7.7. post a photo or video recording of another student or parent on social media without consent;
- 7.8. post a photo or video recording of a child that is not their own on social media without obtaining consent from the child's parent beforehand;
- 7.9. intimidate, undermine, threaten, bully or harass other students or parents; or
- 7.10. disclose the personal details of a student or parent to another person without consent.
